- Borrowers can request up to **two** items at a time.
- Materials are available for a **four-week period**. A two-week extension may be allowed as long as it does not interfere with other requests.
- The State Historical Society of North Dakota (SHSND) will ship materials as needed, but borrowers are responsible for any return shipping expenses. Items may also be returned in person to the Communication and Education Division at the North Dakota Heritage Center in Bismarck.
- The SHSND reserves the right to decline requests at its discretion.
- Borrowers are responsible for replacement of damaged or missing materials.
